The nature of personal information we collect may include:

- Your name and address
- Your phone number and email address
- Address where service is needed (if different from the address where you live)
- Your date of birth for identification purposes only
- The name and information details about an additional person to be added to the account
- Banking information if you enrol in the pre-authorized payment plan
- The name of any third party that you want to have access to the account

Essex Power uses the information we collect for the following purposes:

- To provide you with continuous electric service and to bill you for electricity, water and sewer services;
- To assist us in the collection of accounts;
- To respond to your inquiries about electricity, water and sewer use and billing;
- To prevent fraud with respect to both you and our company;
- To meet legal and regulatory requirements.

Because of the structure of the electricity sector in Ontario, it may be necessary to share your electricity billing and consumption information with third party billing and settlement agencies. For example, your electricity billing and consumption information may be provided to a retailer with whom you have chosen to enter into a separate contract. Your information may also be disclosed or shared with other agencies or organizations as required by law or regulation.

We have developed and implemented a Corporate Privacy Policy for maintaining the confidentiality and security of your personal information. At any time, you have the right to request access to your personal information which we have collected and to request amendments to personal information about you to ensure its accuracy and completeness.
